The Center investigates how the interplay of universalist and particularistic concepts has shaped contemporary European history from the 1970s to the present day. It aims at revealing how these concepts have influenced how political and social change was conceived, justified, promoted or even prevented in three different areas: the economy, the religious and the secular, and human rights. The

	center accommodates annual groups of international scholars on the senior and junior level, who combine their expertise in order to arrive at answers that illuminate the past, the present and possibly the future.

	The institute's research program covers a wide range of topics in the long history of the former Bohemian and Moravian Lands, today's Czech Republic and Slovakia. Research staff includes eight senior fellows, six research positions acquired through third-party funding, and five positions for library staff and administration. The institute accommodates a substantial library, and further obligations include the editing of a scholarly journal and several long-term projects, such as handbooks and dictionaries. Its annual budget amounts to 1.3 million euros of regular funding; over the past ten years, this was complemented by successful third-party fundraising (300.000 EUR on average). In addition to the institute's headquarters in Munich, since 2018 the institute has a branch in Prague (as a result of successful advocacy).

# INTERNATIONAL MASTER'S PROGRAM "EASTERN EUROPEAN STUDIES"

- Since 2003: Principal applicant, head, speaker and architect of a Master's degree program "Eastern European Studies", which received long-term funding through the Elite Network of Bavaria ("Elite-Studiengang"; www.osteuropastudien.de).
- The program is interdisciplinary (history, Slavic studies, social sciences, cultural studies), it is organized as a regional collaboration between LMU Munich and the University of Regensburg, and still ongoing. Since its inception, 330 students have graduated, and the placement record is excellent.
- The program entails annual **summer schools** (2 weeks) in different Eastern European locations, which are often co-organised with local partners. The speaker so far has been responsible for 19 of these summer schools in total, and has designed, organized, and conducted five of them in particular:

#### ACTIVITIES AS CO-SPEAKER OF THE GERMAN-UKRAINIAN HISTORICAL COMMISSION

- After Russia had annexed Crimea in 2014, Martin Schulze Wessel initiated the founding of a German-Ukrainian Historical Commission, which started in Feb. 2015 (<u>https://www.duhk.org</u>).
- Activities in line with other joint Historical Commissions included collaboration between historians in both countries and the promotion of early career scholars in both countries.

# ENGAGEMENT FOR INTERNATIONAL COLLABORATION IN THE HUMANITIES

- All of Martin Schulze Wessel's **major research projects** (see above; many of them major group initiatives) have aimed at fostering international collaboration in the field.
- Martin Schulze Wessel has actively contributed to international **historical commissions** (German-Ukrainian and German-Czech and German-Slovak Historical Commissions).
- As Director of the Collegium Carolinum and Chair of the Historisches Kolleg, Martin Schulze Wessel
  has successfully internationalized the structures of both institutions, including international members
  to both institutions' Scientific Advisory Board (See for Collegium Carolinum: <a href="https://www.collegium-carolinum.de/institut/verein/wissenschaftlicher-beirat">https://www.collegium-carolinum.de/institut/verein/wissenschaftlicher-beirat</a>; Prof. Diana Mishkova (Sofia) joined the Board
  of the Historisches Kolleg.)
- As Chair of the **German Association of Historians** (VHK), Martin Schulze Wessel introduced the element of international panels, which were collaboratively organized with history associations from other countries. This included panels with British historians at the Historikertag in Göttingen 2014, and panels with India as international partner in Hamburg 2016. The partnership with the historians' association in India (the first time that a Historikertag partnered with the global south) was initiated, and negotiated, by Martin Schulze Wessel in New Delhi. In 2017, he was invited to the Indian Historians' Convention in return (as keynote speaker).
- Since 2022 Martin Schulze Wessel is member of the advisory board of the "Yehudit and Yehuda Elkana Fellowship Program to Promote Free Scientific Exchange" of the Wissenschaftskolleg zu Berlin
- In the area of German-Ukrainian relations, Prof. Yaroslav Hrytsak (Catholic University of Lviv) and Martin Schulze Wessel are establishing a research center that will structurally strengthen academic relations between the Catholic University of Lviv and LMU Munich. The center will investigate the history of mass violence in Ukraine in the 20th century. It is the only humanities project to have been selected for funding by the Federal Ministry of Education and Research in December 2023 and will start on April 1, 2024.
